Dear members,

The erstwhile State Bank of Patiala OBC Employees' Welfare Association registered in the year 2016, since our Association clinched all benefits at par with Government of India Guidelines. I appeal to all our members working in State Bank of India in Chandigarh Circle, please join & strengthen the Association and to achieve benefits as per Government Guidelines.

Within the Short span of time of 1 year of our struggle and with the support of the Government of India, we clinched the following benefits:

- 1. Providing Pre-Promotions Trainings:- i) to Sub staff to Clerical, ii) Clerical to Officer Cadre & iii) JMGS to MMGS-II
- 2. Conducting a day's work shop for Office Bearers to create awareness in respect of the welfare measures to be extended as [per Government guidelines.
- 3. Liaison Officer:-

Chief Liaison Officer at Head Office -General Manager Cadre, Liaison Officer in AO /ZO-Chief Manager ZOCC & Liaison Officer in RBO -Chief Manager (GB)

- 5. To ensure 27% reservation in recruitment for OBC category in all posts and services.
- 6. Ensuring candidates recruited on the basis of merit in an open competition on the same standards prescribed for the general candidates shall not be adjusted against the reserved quota for OBCs.

- 7. To ensure proper carry of forward unfilled reserved vacancies, due to non-availability of OBC candidates for period of 3years.
- 8. Launching special recruitment drive filling up the backlog vacancies for OBCs, wherever necessary.
- 9. Upper age limit prescribed for direct recruitment shall be relaxed by 3 years in respect of OBC candidates.
- 10. A separate OBC Cell at Head Office, Liaison Officer preferably belongs to OBC Category will be posted to look to ensure implementations the reservations and other welfare measures taken up by the Government for OBC employees.

After merger of State Bank of Patiala with State Bank of India, State Bank of Patiala OBCs Employees Welfare Association has been renamed as "State Bank of India OBCs Employees Welfare Association- Chandigarh Circle. We have been struggling for recognition in State Bank of India and getting all the Government guidelines for welfare of OBC Employees implemented. Shortly, the Bank will accord its recognition to OBC Welfare Association. It would be a milestone in the History of State Bank of India.

The following welfare measures and facilities in addition to as above mentioned for which, we have been struggling with the management of State Bank of India since just of merger are as under:

- 1. Providing Check off Facility (monthly subscription deduction from salary & credit Association Account).
