

## NOTICE IN CONNECTION WITH CONDUCTING ELECTION OF STATE BANK OF INDIA OBCs EMPLOYEES WELFARE ASSOCIATION - CHANDIGARH CIRCLE

The tenure of the existing executive body of State Bank of India OBCs Employees Welfare Association – Chandigarh Circle will on over in May 2023. As per terms of the constitution of the Association, new executive body is to be elected before expiry of the tenure of existing body.

A meeting of the executive committee members of the Association was held on 14.04.2023 (Friday) through online (Zoom Portal). More than 40 executive committee members were present in the meeting.

The following was decided in the Meeting:

- 1. The election for new executive body to be conducted well before the expiry of the tenure of the existing body.
- Three (3) members election committee has been formed comprising One (1) President, One (1) Secretary & One (1) Member. Mr. Mukesh Kumar Saini has been appointed as the President of the election committee and also let him authorize to select other two (2) members of the committee and take all the decision for conducting free and fair election unanimously.
- 3. Sh. Jai Prakash Gupta (AGM- Rehbu) has been appointed as Presiding/Returning Officer for the election unanimously.

Mr. Mukesh Kumar Saini (President of election committee) has appointed Mr. Mahesh Kumar Yadav (RBO-3) Patiala as Election committee secretary and Mr. Ramesh Kumar Patel (Airawat Branch) as Member of the committee.

Sh. Jai Prakash Gupta (AGM- Rehbu) has given his consent as well as acceptance for appointing him as Presiding/Returning officer for the election of State Bank of India OBCs Employees Welfare Association Chd. Circle.

The Presiding/Returning officer has authorized Mr. Mukesh Kumar Saini (President) Election Committee to issue the schedule of election, voter list, List of the posts and Nomination form after duly approval from him and get all these uploaded at <a href="https://www.sbiobcchd.org">www.sbiobcchd.org</a> for public notification. The committee will receive the nomination forms from all the aspiring contestants for handling over to the presiding officer for scrutiny and taking final decision.

The Election Committee has suggested the following modalities to conduct of election.

- 1. On behalf of presiding officer, General Secretary will get the schedule of election, voter list, List of the posts and Nomination form uploaded on our website i.e. <a href="www.sbiobcchd.org">www.sbiobcchd.org</a>. The contesting candidate will have to submit his/her nomination form through email at (sbiobcchd@gmail.com) or by post at #545, Urban Estate, Phase -II, Patiala the duly filled and signed nomination form (scan copy) along with the signature of another member as proposer. (Original copy is to be sent by post).
- 2. The nomination is to be submitted to the presiding officer by 08.05.2023.
- 3. Only an employees of OBC category (who is member of the Association) posted in any of the branches/office of State Bank of India, Chandigarh Circle will be eligible for contesting the election and voting.
- 4. After scrutiny of the nomination forms, the presiding officer will upload the list of contesting candidates on our website and also upload specimen of the ballot paper on our website.
- 5. Only the OBC employees who are being shown in the electoral list are eligible for contesting the election and for casting his/her vote in the election.
- 6. The election is to be conducted through ballot paper at the venue of General Body Meeting at Prabhat Parwana Trade Union Centre, Opp- Circuit House, Patiala on 27th May 2023.
- 7. After due scrutiny and counting of the votes in presence of the Presiding officer and one independent observer who is not related in any way with the affair of election, the Presiding Officer will declare the name of Post wise elected candidates. The result will be declared in the General Body Meeting and placed on our website ie. <a href="https://www.sbiobcchd.org">www.sbiobcchd.org</a>.
- 8. In case of any dispute arise, decision of the presiding officer will be final and binding on all the concerns.

The OBC employees, who have not submitted their membership form and want to contest the election, may submit their membership form by 30.04.2023.

The aspiring contestants are requested to submit their nomination form as attached below by 25.04.2020.

The Presiding officer will only take the task in their hands once the hard copy of nominations is hande over to him.
